## SPECIAL PROVISIONS

---

### *Article 1*

Financial support from Regulation (EC) N° 614/2007 of the European Parliament and of the Council of 23 May 2007 concerning the Financial Instrument for the Environment (LIFE+) is hereby granted to project proposal No **XXX**, title: **XXX**, received on 00/00/0000, (“**the project**”) as described in Annex I.
